2. Update from Ward members.

Ward Councillors asked if Loversall would like any Trees? Barret Homes in Tickhill have a surplus. Various places for them to be planted was discussed.

Tickhill – A new sluice gate was being fitted and completed by Christmas to alleviate flooding in the area.

Stainton – 400 New houses have been granted permission. Anoth 300 towards Maltby has been proposed Ward councillors were attending planning meetings about this.

Braithwell – Active travel Cycle Paths, will eventually join up around the areas. The Butchers Arms car park has proposals for 2 houses. Land registry was being investigated.

Woodfield/Dominion – 20/30 more house being built with 106 monies. Barriers are in place to stop quad bikes. Pedestrian crossing was needed for the Academy School.

Sewage system was currently a problem with Yorkshire Water repairing before any adoption of roads by Doncaster Council.

If a merger was to take place with Loversall, there would be monies available for the area. To clean up areas and reinstate the Cricket Green.

Any mergers would be discussed prior to this. Ward councillors reported they were actively seeking advice from YLCA. These would take place in the next 2-3 months.

Loversall Parish Council are opposed to any mergers.
